PROGRAM OVERVIEW

Requirements and expectations for program participation and completion: Participation:

- Summer
 - Before School Year: Attend three-week Summer Intensive July 16-27 (one week online, two weeks face-to-face)
- School Year
 - Teach in a classroom with ELs (or obtain access)
 - o Multiple observations of your video exemplars of your classroom practice
 - o Four observations you conduct in a certified EL teacher's classroom
 - Develop and implement an individualized learning plan (CLIP)
 - o Participate in quarterly Community of Reflective Practice (CORP) meetings
 - Meet with the Learning Guide on a consistent basis, either online or face-to-face to plan and assess progress
 - Lead a session in a spring EdCamp

Assignments:

- Development of a comprehensive **Candidate Learning and Implementation Plan** and submission of evidence to demonstrate competency in Domains 1.a.1 through 5.b.7**; planning sessions with Learning Guide to develop appropriate learning experiences and evidence. Minimum, required evidence is indicated below.

 - o Domain 2
 - NCCREST Self-assessment and goal-setting
 - Self-audit of culturally competent classroom

- O Difference or Disability: mini-module and Action Plan
- Candidate and Learning Guide will determine additional artifacts to submit as evidence for all indicators.
- Dispositional self-assessment pre, mid, and final, and more as needed
- Three or more TESOL standards self-assessments at least pre, mid, and final
- Two Teacher Work Sample assignments
- Online Discussion Board responses for each Domain in modules as assigned by LG
- Readings as assigned in CLAD modules and by LG, including:
 - Making Content Comprehensible for English Learners: The SIOP Model by Echevarria, Vogt, & Short;
- Gottlieb (2016) Assessing English Language Learners Bridges to Educational Equity - SECOND Edition
- Differentiating Instruction and Assessment for English Language Learners: A

 (Total cost = approximately 72\$)

Tuition:

- The cost of the program is \$3500 for one year. If a candidate does not meet or exceed all competencies within the year, she/he will need to re-enroll and pay for a second year.
- Required books cost a total of \$72 (currently on Amazon).

APPLICATION REQUIREMENTS

- Completion of application;
- Copy of valid RI Elementary or Secondary Educator certificate;
- Two recommendations to attest to the candidate's commitment, professionalism, and anticipated success in self-paced coursework. Please see the Admissions Rubric;
- Undergraduate or graduate official transcript with degree gpa of 3.0;
- Submit one application essay: 200-300 words, 12pt font, double-spaced; please indicate why you would like to become certified as an ELL teacher.
