8. Are hand delivered responses/packages allowed or must they be mailed?

9. How much time do elementary schools have with their students each day to focus on ELD instruction?

45 minutes/ day

10. Are students in elementary school grouped by grade level or language proficiency level?

Students at the elementary level can be grouped for ELD by grade if they are within two consecutive Overall Proficiency levels on ACCESS or the WIDA screener. For example, an ELD group of 1<sup>st</sup> graders may be grouped together if all students within that group have an overall proficiency level between 1.0-2.9 on ACCESS, or 2.0-3.9 on ACCESS, or 3.0-4.9 on ACCESS, etc.) OR students can be grouped across two consecutive grades, but if that is done, they must be within the same proficiency level range. For example, ELD for a group of 2<sup>nd</sup> and 3<sup>rd</sup> graders who are all between 1.0-1.9 on ACCESS is allowed.
